

SUMMARY ANNUAL REPORT FOR NATIONAL LIFE INSURANCE COMPANY GROUP INSURANCE PLAN FOR HOSPITAL

This is a summary of the annual report of the National Life Insurance Company Group Insurance Plan for Hospital, a health and dental plan (Employer Identification Number 03-0359222, Plan Number 504), for the plan year 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

NLV Financial Corporation has committed itself to pay certain medical and prescription claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Cigna Health and Life Insurance Company And Life Insurance Company Of North America to pay certain Health, Prescription drug, Stop loss, Indemnity Contract, Voluntary Hospital Care claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2020 were \$972,405.
